Greetings BANA ASC family. It is a great day to be alive and clean!

I wanted to provide a follow-up to the Policy Voting question from last month's meeting. I have reread the BANA Policies and discussed the issue with our predecessors that wrote the Policy. The current policy for voting to change policy is in Section 4, C, 1,b and reads as follows: "Area issues that affect NA as a whole. ..The vote will be by a simple majority." Section 4,C,3 is a little confusing because it references section 10, Amendments to Policy. However, there is no applicable Section 10 and this is a typo in the existing policy and we may want to correct this when we update the Policy.
